Neighbour arrested for killing minor had joined search party looking for her: Gujarat Police

AFTER THE body of a minor girl who went missing two days ago was found stuffed in a bag in Gandhinagar district, the Gujarat police on Friday said it detained four suspects and one of them admitted to the murder, leading to his arrest. The police said the arrested accused, 36, was a neighbour of the victim.

A statement issued by the police on Friday said the girl's parents went out for work on November 12, leaving their son and daughter at home.

By the time they returned, their daughter had gone missing and they filed a police complaint.

A team of around 40 Police and Home Guard personnel began a search for the girl on the streets as well as through technical means and human intelligence.

On November 12 night, an additional 40 personnel were deployed to search for the girl. A drone was also deployed but to no avail.

After nearly 36 hours, on the night of November 13, the police received information that the body of the girl had been found stuffed in a gunny bag, in an open space near her home.

Senior police officers reached the spot. After identification of the body, the nature of the investigation changed - from the search for a missing girl to the hunt for her murderer.

The forensics laboratory deployed a fingerprinting team and the police's dog Squad was also called in. Investigators from the Local Crime Branch (LCB) and Special Operations Group (SOG) were also called into the case. The body was sent for post-mortem and Additional Superintendent of Police (ASP) Ayush Jain of Dahagam Division said the post-mortem results would ascertain if the victim had been sexually assaulted.

The police rounded up neighbours and suspicious persons and began interrogation. They trimmed the list down to four persons, ASP Jain had told *The Indian Express* on Friday.

{'SAALMARADA' THIMMAKKA + 1912-2025} Environmentalist, Padma Shri recipient Thimmakka dies at 114

PADMA SHRI awardee and environmentalist 'Saalmarada' Thimmakka passed away at a private hospital here on Friday. The 114-year-old was ailing for quite some time and was hospitalised for treatment where she breathed her last, her family sources said.


Born on June 30, 1911, Thimmakka earned the fame 'Saalmarada' after she planted 385 banyan trees all along the 4.5 km stretch between Hulikal and Kadur in Ramangaraya headquartered Bengaluru South district.

With no formal education, Thimmakka started the campaign as she treated the plants as her children to fill the void in life for being childless.

For her work, she received 12 awards, including Padma Shri in 2019, Nadia award from the Hampi University (2010), National Citizen Award (1995) and Indira Priyadarshini Vrishamitra award (1997).

In his condolence message, Chief Minister Siddaramaiah said, "I am deeply saddened to hear the news of the demise of Saalmarada Thimmakka. In thousands of trees and nurtured them like her own children, dedicated most of her life to environmental conservation."

Former Prime Minister H D Deve Gowda, Union Minister D Kumaraswamy, Deputy CM D K Shivakumar, former CM B S Yediyurappa and several other political leaders mourned the demise of Thimmakka.

AHMEDABAD Delhi Crime Branch officer among three booked in graft case

THE GUJARAT Anti-Corruption Bureau (ACB) on Friday said they booked three persons, including an officer with the Crime Branch of the Delhi Police, for demanding a bribe of Rs 80 lakh and allegedly accepting an advance payment of Rs 10 lakh in lieu of discharging an accused in a criminal investigation and not disclosing documents in a case.

The police identified the accused Assistant Sub-Inspector (ASI) Shivkumar of the Crime Branch, Delhi, Chitresh Bhupendra Sutar and Sanjay Patil, both residents of Ahmedabad.

A statement issued by the ACB on Friday said that the complainant as a visa consultant, On July 29, while he was in his office at G Road, the Crime Branch of Delhi Police "raided" the premises. The office and the complainant's vehicle were searched and two laptops and two printers and a total of 17 passports, wallet, Aadhaar card, ATM card, driving licence, voter ID, PAN card, two cheque books and Rs 20,000 were seized from the office.

After that, the complainant and the owner of the firm were taken to Navrangpura Police Station on the charge that the complainant's name had been revealed to a co-accused in an FIR registered by the Delhi Crime Branch.

The statement said, "Meanwhile, ASI Shivkumar called his friend Chitresh Sutar and the owner 'Om Global Tours' called his friend Chitresh Sutar. Both Chitresh Sutar and Sanjay Patil knew each other from earlier. After that, both of them intervened and immediately released the complainant and the owner of 'Om Global Tours', and ASI Shivkumar gave notice to the complainant and the firm owners to appear at the Delhi location to record their statements."

However, the complainant, instead of appearing at the Gujarat ACB and filed a complaint, which led to Inspector S N Barot, Field-3, ACB Ahmedabad, setting a trap in the Paldi area of Ahmedabad, where the transaction was supposed to take place in a car. "Chitresh Sutar had a purposeful conversation with the complainant and was caught red-handed while accepting the bribe amount," said ACB.

'Neecha Nagar' to 'Laal Singh Chaddha': Yesteryear star Kamini Kaushal dies at 98

Mumbai: Actor Kamini Kaushal, one of Hindi cinema's earliest female stars who began her career with the classic *Neecha Nagar* in 1946 and went on to act in a host of films right till 2022, has died in her Mumbai home. She was 98.

Amongst the industry's highest paid actresses in the late 1940s and early 1950s, Kaushal starred opposite the triumvirate of Dilip Kumar, Dev Anand and Raj Kapoor before moving on to character roles in the 1960s. Her last screen appearance was in Anirudh Khan's 2022 film *Laal Singh Chaddha* at the age of 95, making for a remarkable 76 years in the movies.

"She died at her Mumbai home late on Thursday night. She would have turned 99 in November," Sanjiv Narain, a close friend of the family, told PII.

Kaushal, who also crafted puppets and worked actively in storytelling for children, was born Uma Kashyap on February 24, 1927 in Lahore.

The youngest of two brothers and three sisters, Kaushal graduated with a degree in English literature from Government College in Lahore.

She holds the distinction of being the first to come from Lata. Mangeshkar lent her voice for a remarkable 76 years in the movies.

Rope snaps during bungee jumping in Rishikesh; one hurt

A 23-YEAR-OLD man was critically injured after he fell off the rope while bungee jumping in Rishikesh.

The incident took place around 35 metres while bungee jumping at Shivpur Thrill Factory, an adventure sports park, when Soma, who is from Gujrat, fell from a height of around 35 metres while bungee jumping at Shivpur Thrill Factory, an adventure sports park. He sustained injuries to his chest and was admitted to AIIMS Rishikesh.

Police said he has responded to treatment and is out of danger.

Since no complaint has been lodged by the family yet, police said they are yet to file an FIR.

Officers of Muni Ki Reti police station in Uttarakhand's Tehri Garwal said they have constituted a technical team to investigate the reason for the fall.

"Apart from clearances and No Objection Certificates, we have also asked them to undertake an audit from a technical team to investigate the reason for the fall."
